Dear Sir,

This is to inform that the Fund Raising Committee at its meeting held today, *i.e.*, May 4, 2021, approved and adopted the Placement Document dated May 4, 2021 and also approved allotment of 11,53,845 Equity Shares to eligible qualified institutional buyers at a price of Rs. 5,200 per Equity Share, including a premium of Rs. 5190 per Equity Share. The price of Rs. 5,200 per Equity Share takes into account a discount of Rs. 222.94 per Equity Share (4.11% on the floor price) aggregating to approximately Rs. 5,999.99 million, pursuant to the Issue.

Pursuant to the allotment of Equity Shares in the Issue, the paid-up equity share capital of the Company stands increased from Rs. 25,49,63,670 consisting of 2,54,96,367 Equity Shares to Rs. 26,65,02,120 consisting of 2,66,50,212 Equity Shares.

The meeting of the Fund Raising Committee commenced at 7:45 p.m. and concluded at 8:00 p.m.
